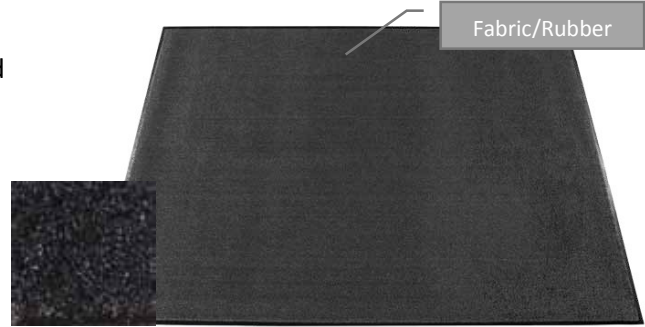


## SURE STEP MAT

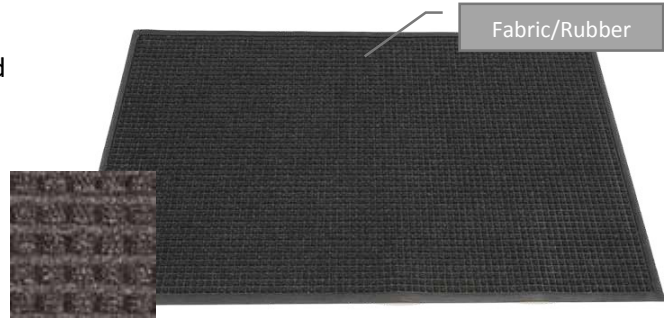


## AQUA DAM MAT

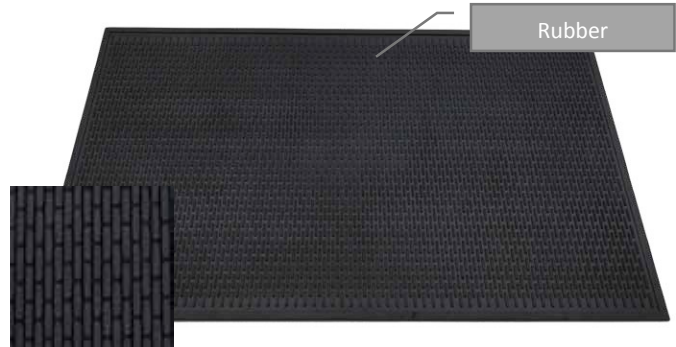


## DIRT STOPPER MAT

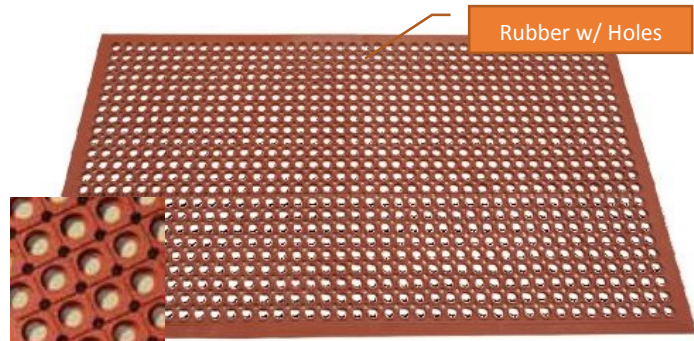


## SAFETYFLO MAT

# Buying vs. Renting Floor and Entrance Mats

When it comes to matting for the office or businesses, consumers have two choices: buying or renting. Although renting might sound like a good option, rental floor mats can actually end up costing far more than purchased mats. Some factors worth consideration include:

**Maintenance** — Most businesses already have their floors cleaned daily and this is enough to maintain floor mats as well. Furthermore, business owners must clean rental mats if they become soiled in between scheduled pickup times. Rental companies also do not launder or replace anti-fatigue, kitchen or scraper mats, so businesses must incur the cost of cleaning those mats, in addition to paying the rental fee.

**Quality and Appearance** — Rental companies provide floor mats in limited styles and colors, which may

result in having to select a mat that is not a good fit for a business' space or décor. Rental companies may reuse mats for years, leaving renters with inconsistent quality.

**Eco-Friendly** — When factoring in the fuel used to pick up mats for laundering and returning them, plus the water and chemicals used in cleaning them, rental mats have a significantly larger environmental impact than purchased mats.

**Cost** — This is the biggest consideration when planning for floor matting. For example renting a 3' x 5' floor mat for five years can cost almost 10 times the amount of purchasing just one mat. Entrance and floor mats are one of the first items people notice when they step into a facility, so the quality and appearance of these mats are vital to making a good first impression.
